# ORDER

- 1. University vide paper read (1) above, invited applications from the affiliated colleges for granting Continuation of Provisional Affiliation for the academic year 2024-25.
- 2. In response to the above notification, undermentioned 16 dental colleges in Table No. I and II had submitted their application with required documents and remitted necessary fee.
- 3. University conducted inspection at these colleges and the reports of the inspection commission were scrutinized by the Scrutiny Committee in its meeting held on 30,01,2024 and recommended to grant Continuation of Provisional Affiliation to 13 Dental Colleges for conducting Dental UG and PG courses with the intake mentioned against each shown in the table No. I below for the academic year 2024-25.
- 4. The recommendations of the Scrutiny Committee were placed before the Governing Council meeting and vide decision read 2<sup>nd</sup> above, Governing Council has resolved to grant Continuation of Provisional Affiliation to below mentioned 13 colleges for the academic year 2024-25, subject to receipt of recognition / renewal permission from Govt. of India, Ministry of Health and Family Welfare for conducting the Dental UG and PG courses.
- 5. Govt. of India, Ministry of Health and Family Welfare has granted recognition / renewal permission for conducting the Dental UG and PG courses at these i3 dental colleges.

- 6. Inspection reports received from Annoor Dental College, Moovattupuzha and MES Dental College, Perinthalmanna were scrutinized on 09.05.2024 in detail and Scrutiny committee recommended to grant Continuation of Provisional Affiliation to these colleges for the AY 2024–25.
- 7. The inspection report from Govt. Dental College, Kottayam was scrutinized on 30.01.2024 and found deficiency in faculty position. Hence the matter was intimated to the college for rectification. Subsequently the college submitted compliance report along with the undertaking from Director of Medical Education, and the same was scrutinized on 09.05.2024 in detail and Scrutiny committee recommended to grant Continuation of Provisional Affiliation to Govt. Dental College, Kottayam for the AY 2024–25 .
- 8. The below mentioned 3 Dental Colleges are having Recognition from Ministry of Health and Family Welfare, Govt. of India, for conducting Dental UG and PG courses with the intake mentioned against each in the table No. II below for the academic year 2024–25.
- 9. The recommendations of the Scrutiny Committee were placed in the Governing Council meeting dated 29.05.2024 and vide decision read 3<sup>rd</sup> above, the Governing Council has resolved to grant Continuation of Provisional Affiliation to the following 3 Dental Colleges for conducting Dental UG and PG courses with the intake mentioned against each shown in the table No. II for the academic year 2024–25.

10. Accordingly, orders are hereby issued granting **Conditional Continuation of Provisional Affiliation** to the above mentioned 16 Dental Colleges for conducting Dental UG and PG courses with the sanctioned intake mentioned against each shown in the above tables for the academic year 2024–25. *The Conditional Continuation of Provisional Affiliation now granted will be confirmed only on submission of an affidavit by the colleges with respect to levying of GST in the prescribed format within 3 months of the date of this order.* 

11. As per the clause 2(5) (ix)(16) of the amendment of the Ist Statute on the matter of Affiliation of Colleges, 'if conditional affiliation is granted, conditions to be fulfilled and the time fixed for fulfilment of the conditions shall be specified in the order of the Governing Council granting affiliation. If the conditions are not fulfilled by the end of the period fixed, the affiliation shall cease automatically. If the conditions are fulfilled, the Governing Council shall confirm the affiliation the end of the period." the power to have

12. The college shall strictly adhere to the conditions detailed below:-

- i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University / Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- ii. In the light of the direction of the Hon'ble Supreme Court of India in writ petition (C) No.656/1998, the Institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the college will be initiated.
- iii. Affiliation granted is strictly provisional and only for the academic year 2024–25. The colleges have to apply for Continuation of Provisional Affiliation for the ensuing years remitting the fee fixed by the University, along with copy of the letter of approval from apex bodies concerned.
- iv. The colleges should remit annual administration fee fixed for UG /PG courses for the academic year 2024-25, if applicable.
- v. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- 13. The Governing Council decision No. 78.15 and 79.11 are hereby implemented.
